

LEGAL BASES FOR PARTICIPATION IN THE COMMUNITY DAYS SWEEPSTAKES

1.- COMPANY ORGANIZING THE SWEEPSTAKES

The Company Pair of shoes, S.L with address at Plaça Universitat 8, ent-2, 08007 Barcelona and identified with the number B62085477 organizes the sweepstakes (hereinafter, the "SWEEPSTAKES"), to be developed through Instagram, in accordance with the provisions of the participation requirements section.

The purpose of this sweepstakes is to reward customers and followers of the brand.

2.-STARTING DATE AND ENDING DATE

THE DRAWING will begin on November 23rd and will end on November 26th, with a daily drawing during that period.

3.- PARTICIPATION REQUIREMENTS AND MECHANICS OF THE RAFFLE

The participation requirements are as follows:

- Participation will be open to those persons who are over 18 years of age.
- Only participants who have an Instagram account will be able to participate.
- Participants must comment on the brand's publication on the social network Instagram tagging 2 friends during the participation period.
- Participants may only participate with a single Instagram profile. If a participant is detected participating with multiple Instagram profiles they will be disqualified.
- Even if participants write several comments on the same post, they will only participate with a single entry in the random drawing.
- The application will accumulate mentions and hashtags of the same participant, even if they are in different comments.

4.- SWEEPSTAKES CONDITIONS AND PRIZES

The winner will be chosen randomly through a platform. The winner will be communicated the following day through the brand's social profiles.

The prize will consist of a discount coupon for 100% of the total amount of an order that only includes a pair of the web catalog. The prize cannot be exchanged for cash or any other prize, nor can it be subject to change or alteration. The Company reserves the right to modify the prize if on the day of declaring the participant as the winner there were problems of stock of this and, therefore, impossibility of being able to give the same.

The celebration of the draw, as well as the awarding of the prize are subject to current tax regulations.

5.- DISQUALIFICATIONS AND PENALTIES

If it becomes evident that any of the participants do not comply with the requirements of the rules, or the data provided to participate were not valid, their participation will be considered null and void and they will be automatically excluded from the DRAW, losing all rights to the prizes awarded under the DRAW.

The Company reserves the right to declare the sweepstakes void.

6.- PUBLICATION OF COMMENTS OR OPINIONS

Comments or opinions whose content is considered inappropriate, offensive, abusive or discriminatory or that could violate the rights of third parties will not be allowed. Comments against an individual that violate the principles of the right to honor, personal and family privacy and self-image will not be allowed. We will not be responsible for any damage caused by the comments made by the participants in the SWEEPSTAKES, and that at any time could hurt the sensitivity of other participants.

The participation in the SWEEPSTAKES, as well as the publication of the comments made by the Participants in the publications may not violate under any circumstances the Instagram Community Rules or the Instagram Terms of Use.

If the Company discovers the use of fraudulent means for participation, such as the use of bots in the comments, the prize will not be awarded and will remain the property of the Company.

7.-EXONERATION OF RESPONSIBILITY

8.- PROTECTION OF PERSONAL DATA

Without prejudice to any other administrative remedy or judicial action, the participant shall have the right to lodge a complaint with a Supervisory Authority, in particular in the Member State in which he/she has his/her habitual residence, place of work or place of the alleged infringement, in the event that he/she considers that the processing of his/her personal data is not in accordance with the regulations, as well as in the event that the exercise of his/her rights is not satisfied.

It is for this reason that the participant declares to have been informed of the conditions on the protection of personal data by accepting and consenting to the treatment.

9.- CHANGES AND ACCEPTANCE

We reserve the right to modify or extend these promotional terms and conditions, to the extent that it does not prejudice or undermine the rights of the participants in the SWEEPSTAKES.
